1. Call to Order and Citizen Comments: Chairman Liberty called the meeting to order at 3:30pm. No Citizen Comments.


There was a need for a closed session. Councilman Rice made a motion to enter into closed session. Councilman Wilson seconded the motion. Committee entered closed session at 3:31pm.

Committee entered back into open at 4:36pm.

- 2. Approval of minutes- March 11, 2021- Councilman Wilson made a motion to approve the March 11, 2021 minutes. Councilman Rice seconded the motion. Motion passed.
- 3. Grant Update- Chief Cordova discussed the Youth Alcohol Enforcement Campaign. The Police Department was awarded \$1,100 in grant funds for this campaign which begins April 30, 2021 and ends May 9, 2021.
- 4. Employee/Personnel Updates- Mr. Doyle stated that there is a need to schedule interviews with three applicants for an open position at the Police Department. Chief Cordova would like to set up with committee and applicants as soon as possible to ensure that the Police Department is fully staffed.
- 5. Other Business- Chief Cordova discussed a lease purchase option for three new patrol cars. Mr. Doyle discussed an option with a fleet management company which could be more beneficial. Committee would like to bring information on Fleet management company back to next meeting and would like budget figures for the Police Department to see if this will be a better option.

Having no further business, Chairman Liberty adjourned the meeting at 4:58pm.

Next meeting is scheduled for May 13, 2021 at 3:30pm.





Allows riders to have ultimate flexibility and ride anywhere within the designated 'operating zone'.


Follow prompts on the app and park in the "furniture zone" out of the way of pedestrians and ensuring ADA compliance.





#### **Bird Access**


Discount program available to low-income riders for those who are enrolled or eligible for a government assistance program.



#### Memorandum of Understanding

The City of Waynesville will permit Bird Rides, Inc. to provide ser	vices under the follow	/ing			
terms and limitations. This agreement shall remain in effect until	date	unless			
terminated as set forth below.					

#### **AGREEMENT**

- 1) Scope: This Agreement and its terms apply to any proposed deployment of Stand-up electric scooter sharing systems within the City of Waynesville's jurisdictional boundaries. No person shall deploy a Stand-up electric scooter sharing system in the City of Waynesville in violation of this Agreement.
- 2) Stand-up electric scooters shall be governed by the rules applying to bicycles and are to be ridden on streets, and where available, in bike lanes and bike paths. Stand-up electric scooters are to stay to the right of street lanes and to offer the right of way to bicycles in bike lanes and on bike paths. Users of Stand-up electric scooters shall be 18 or older. Users of Stand-up electric scooters who violate these provisions may be fined by the City of Waynesville's consistent with fines for cyclists.
- 3) Bird Rides, Inc. shall provide easily visible contact information, including toll-free phone number and/or e-mail address on each Stand-up electric scooter for members of the public to make relocation requests or to report other issues with devices.
- 4) Hours of operation: Stand-up electric scooters will be made available to rent from 4 a.m. to midnight (local time)
- 5) Bird Rides, Inc. shall provide a minimum of 50 / 100 vehicles at launch.
- 6) Safety Education: Bird Rides will provide materials, videos, signage to promote safe riding and educate riders on rider responsibilities and encourage safe and courteous riding and parking.
- 7) Data sharing: Bird Rides, Inc. will provide data to the City of Waynesville as necessary to assist with monitoring program usage.
- Indemnification: Bird Rides, Inc. agrees to indemnify, defend and hold harmless the City of Waynesville (and the City of Waynesville's employees, agents and affiliates) from and against all actions, damages or claims brought against the City of Waynesville arising out of Bird Rides, Inc.'s negligence or willful misconduct, except that Bird Rides, Inc.'s indemnification obligation shall not extend to claims of City's (or City's employees', agents' or affiliates') negligence or willful misconduct. The City of Waynesville expressly acknowledges that in no event shall Bird Rides, Inc. be liable for any special, indirect, consequential or punitive damages. Bird Rides, Inc.'s indemnification obligations shall survive for a period of one (1) year after expiration of this Agreement. Bird Rides, Inc. shall be released from its indemnification obligations under this section if the loss or damage was caused by the City of Waynesville's negligent construction or maintenance of public infrastructure. The City of Waynesville's right to indemnification shall be

contingent on City of Waynesville notifying Bird Rides, Inc. promptly following receipt or notice of any claim; Bird Ride, Inc. shall have sole control of any defense; The City of Waynesville shall not consent to the entry of a judgment or enter into any settlement without the prior written consent of Bird Ride, Inc.

- 9) Insurance: Bird Rides, Inc. shall provide the City of Waynesville with proof of insurance coverage exclusively for the operation of Stand-up electric scooters including: (a) Commercial General Liability insurance coverage with a limit of no less than \$1,000,000.00 each occurrence and \$2,000,000.00 aggregate; (b) Automobile Insurance coverage with a limit of no less than \$1,000,000.00 each occurrence and \$1,000,000.00 aggregate; and (c) where Bird Rides, Inc. employs persons within the City / County, Workers' Compensation coverage of no less than the statutory requirement.
- 10) Notices: All notices and communications to the City of Waynesville from Bird Rides, Inc. shall be made in writing (includes electronic communications) and sent to the address below.
- 11) Either party may terminate this agreement at any time and without cause upon (30) days prior written notice.
- 12) In carrying out their responsibilities, the parties shall remain independent contractors, and nothing herein shall be interpreted or intended to create a partnership, joint venture, employment, agency, franchise or other form of agreement or relationship.
- 13) The parties acknowledge that Bird Rides, Inc. may utilize independent business logistics providers to facilitate local operations. Bird's use of these logistics providers does not constitute a transfer or assignment of this Agreement, and Bird Rides, Inc. remains responsible for all obligations and requirements under this Agreement.
- 14) This agreement shall be governed by and construed in accordance with the laws of the State of Missouri.
