

**OFFENSE INFORMATION**

SCR 37.495 Uniform Fine Schedule / Effective January 01, 2020

You have been issued a courtesy summons to appear in the **Waynesville Municipal Court**.

You **MUST** respond to your citation before the court date shown on your citation by either pleading guilty and paying the total fine & costs, or by appearing in court on the date & time specified and pleading not guilty.

**Mandatory Appearances:** If your offense is NOT listed on the "Fine Schedule" that appears on the the right side of this form, you **MUST** appear in court on the date & time listed on your citation.

**TO PLEAD GUILTY AND PAY**

**By Mail:**

1. Sign the *Appearance, Plea of Guilty and Waiver* located on the **back** of your citation.
2. To determine your total payment, refer to the "Fine Schedule" on the right side of this form.
3. Enclose your citation with a check or money order payable to: City of Waynesville

5. If you would like a receipt, you must include a self-addressed stamped envelope.

**In Person:**

You may pay in person at the Waynesville Municipal Center (NOT the courthouse) located at 100 Tremont Center, Waynesville, Missouri. **Bring your citation with you. Due to social distancing requirements, please be prepared for a possible delay when paying.** Methods of payment accepted are cash, check, money order, and credit/debit cards. Please note that a 3% convenience fee of the total payment will be added to all credit/debit card payments processed.
