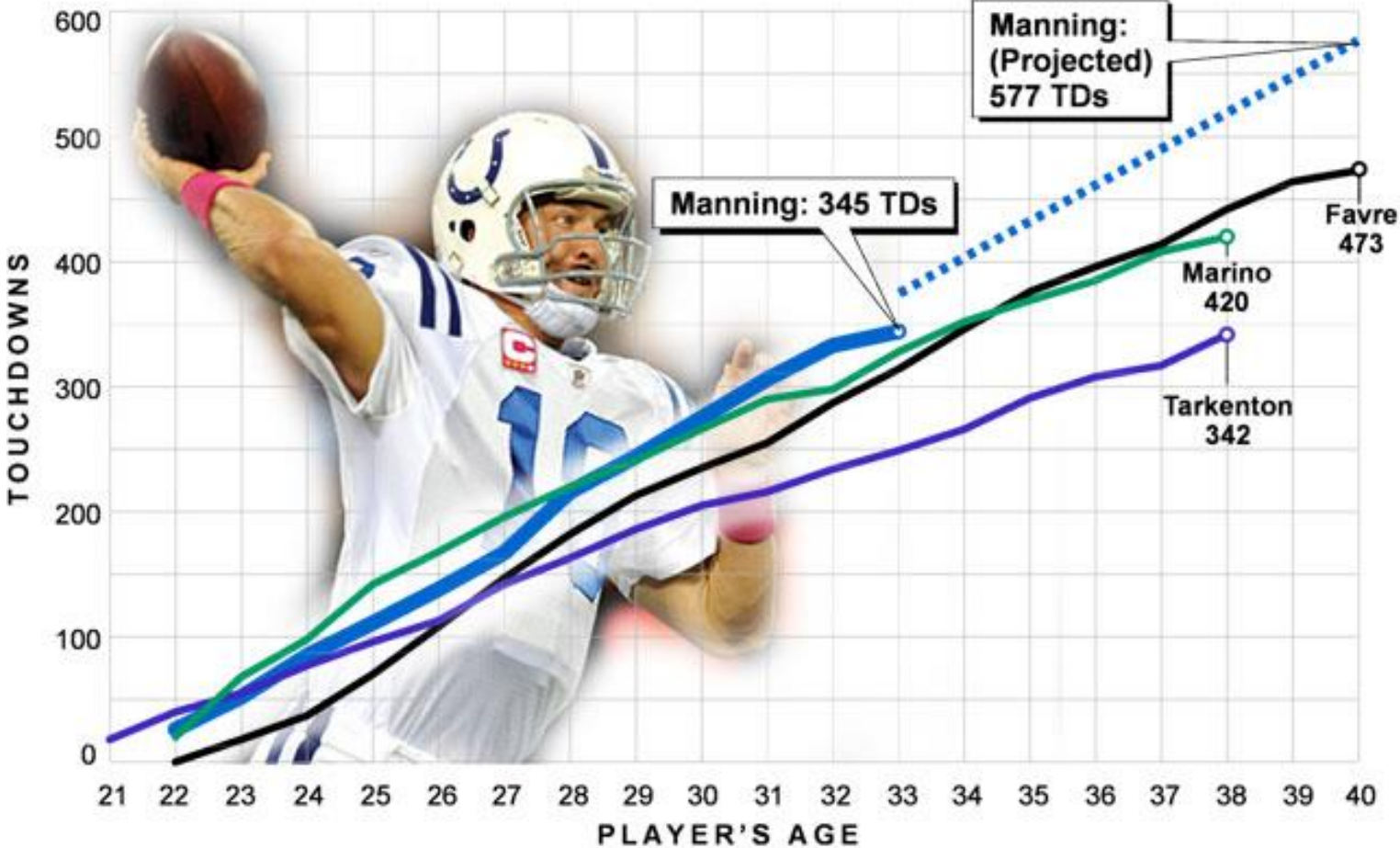
FY 2024 Final Budget

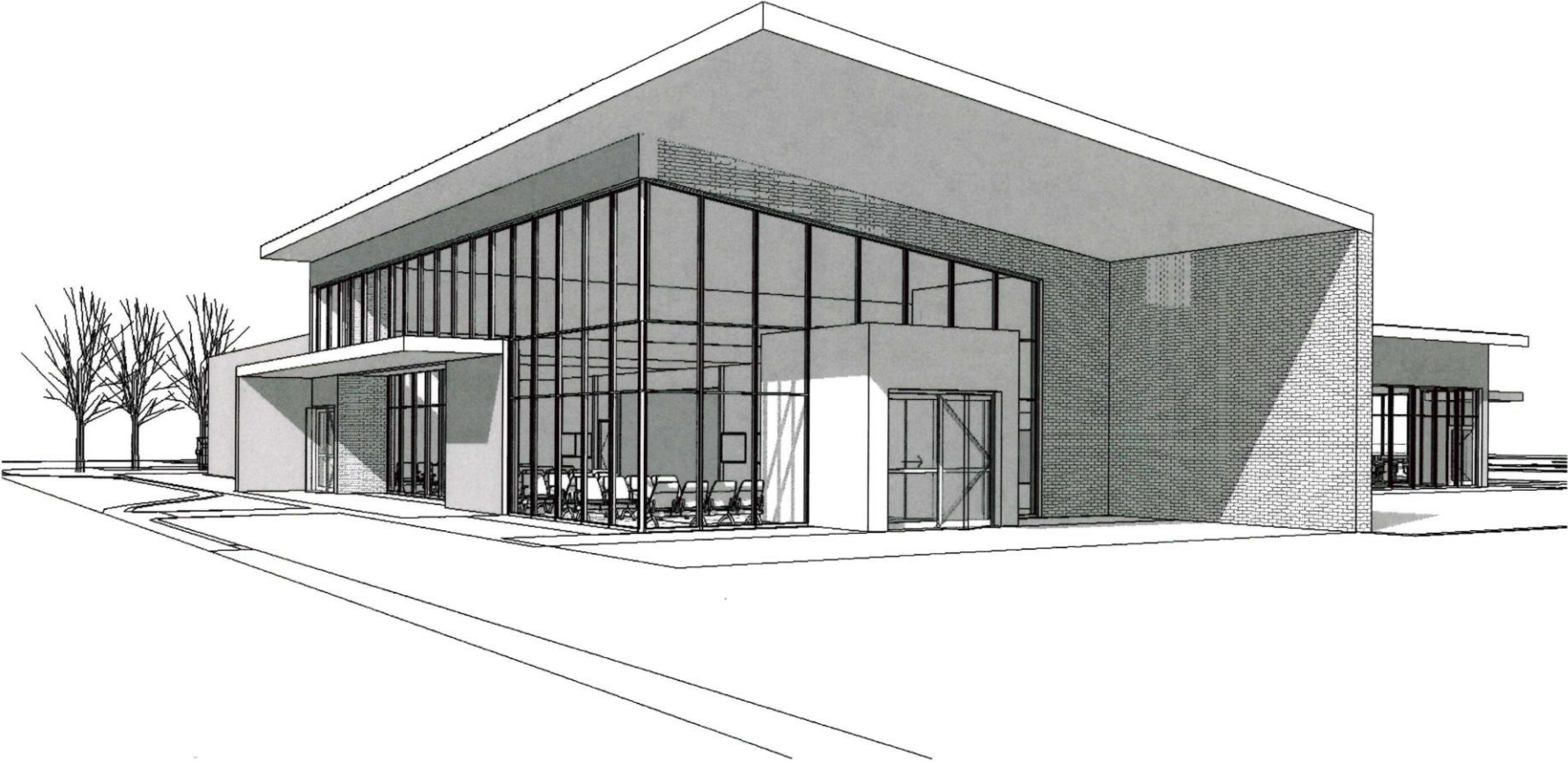
