AN ORDINANCE APPROVING AN AMENDMENT ORDINANCE #2390 CONCERNING AN AGREEMENT BETWEEN THE CITY OF WAYNESVILLE AND CITY OF RICHLAND RELATING TO NATURAL GAS; FIXING AN EFFECTIVE DATE

WHEREAS, the City of Waynesville has heretofore entered into an Agreement with the City of Richland under date of December 15, 1994; and

WHEREAS, Natural Gas reservation and transportation costs have greatly increased over the past twenty-five years; and

WHEREAS, the Agreement between both cities is set to expire on December 31, 2019, and the cities are continuing negotiations for a permanent contract extension.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF WAYNESVILLE, MO AS FOLLOWS:

<u>Section 1.</u> The Mayor and/or City Administrator is authorized to execute an amendment, attached hereto as "Exhibit A", on behalf of the City of Waynesville.

<u>Section 2.</u> The Mayor and/or City Administrator is authorized to negotiate further and execute, on behalf of the City, all documents necessary to make amendments to the said Agreement. The City Administrator is authorized to execute this Amendment and any other documents necessary to complete negotiations with the City of Richland regarding Natural Gas Service in the absence or unavailability of the Mayor.

Section 4. All other provisions of the agreement shall remain in effect.

Section 5. This ordinance shall be in full force and effect from and after its passage and approval.

EXHIBIT A
